

### USPS GPS Requirement

The United States Postal Service has released a letter stating their intention to require real-time trip location reporting using GPS technology. The contractual requirement will apply to a number of network highway contracts and is subject to immediate implementation with a "Go-Live" date set for October 1, 2010.

#### What Information is Required?

The USPS is looking to acquire the updated locations of a postal trip in progress not less frequently than every 30 minutes as well as historical arrival and departure information for the trip. The information is non-proprietary and includes the following fields:

- Supplier name
- Action: Arrival, Departure, En-Route
- Event date/time
- Postal contract number
- Postal trip number
- Trip Location by address or GPS coordinates
- Origin and Destination of each segment

#### **Frequently Asked Questions:**

Q: Can we use our existing phones for the GPS compliance solution? A: You can use any Android based phones. If your phone is based on Android, you can use it.

Q: What wireless carrier is used for the cell phone solution? A: LoadTrek.phone can be used with any carrier of your preference. If you have an existing contract, you can continue using the same carrier.

Q: Do we set up our own wireless plans and acquire phones or are they provided with the solution?

A: If you have existing plans, those can be used, but you may need to add a data plan with new phones. LoadTrek.net can also help you set up new wireless plans and select appropriate phones.

Q: How much work is it to set up the LoadTrek.phone solution? A: First, you can set up Postal Trips which takes about 2 minutes per trip or in some cases, trips may be imported. Next, you train the drivers. LoadTrek.net has on-line training videos on how to use the phone application as well as a paper driver manual. You can be up and running in one week. LoadTrek.net
